

## Celestial Kingdom

### **Basic Event Guidelines**

- 1. All local, state and federal laws will be enforced at all times. Any violation of these laws is grounds for removal from site.
- 2. Only the head of security, the Monarch, or autocrat(s) may remove an individual from site. If a person is asked to leave, he/she will be given 30 minutes to gather his/her belongings and vacate the site. Local authorities will be called upon any refusal to leave site.
- 3. Anyone under the legal drinking age caught drinking alcohol and/or breaking any local, state or federal laws will be detained in a security area. That minor's legal guardian(s) will be contacted and advised to pick the minor up from the event and/or local authorities will be called.
- 4. Disorderly conduct will not be tolerated and may result in expulsion from the designated area. Further non-compliance is grounds for removal from the site.
- 5. Any physical altercations, destruction of property, or refusal to cooperate with security will be grounds for removal from site.
- 6. All camping areas should be kept clean and all trash removed from your campsite before you leave the site.
- 7. Please keep your vehicle locked at all times; we are not responsible for any lost, damaged, or stolen personal belongings.

## Writs of Province

During court, the principality officers will be asked to approach the crown and sign their contracts.

# Amtgard, the Celestial Kingdom, Inc. Summer 2002 Prime Minister Elections Voting Instructions

ur candidates are:

#### Bryana, Clalibus, and Galen

oting in the 2002 Summer Prime Minister Elections will be primarily indled through Individual Park Officers in the following manner:

- 1. Province Officers are to print out a complete list of all members eligible to vote.
- 2. Anyone wishing to vote absentee (sometimes called "proxy") must go to their Province to vote absentee.
- 3. The Province officer has the voter sign by their name on the printed list.
- 4. The Province officer signs a blank piece of paper and gives it to the voter with an envelope.
- 5. The voter then:
  - a. Clearly prints the name of the candidate they wish to vote for on the piece of paper.
  - b. Puts the paper inside the envelope WITHOUT SIGNING IT.
  - c. Seals the envelope.
  - d. Clearly prints their mundane AND persona names on the outside of the envelope.
  - e. Returns the sealed envelope to the Province Officer.
- 6. The Province officer signs the outside of the envelope.
- 7. The Province officer envelopes they have collected and their eligible voter list into a large envelope and brings it to Midreign. It must be turned in to either His Majesty Diego or Prime Minister Kaderian prior to 2 PM on Saturday, August 10.
- 8. Anyone who has not previously voted may do so on site beginning at 3 PM on Saturday, August 10<sup>th</sup>. The polls will remain open until 5 PM. At that time, His Majesty Diego, BOD President Esuom, and Prime Minister Kaderian will each choose one assistant to help count the ballots. The ballot counting will be done by one reader with one watcher and two tallyers each with one watcher. Everyone is welcome to be present for the ballot count.
- 9. The results will be announced as soon as the tallies are reconciled.
- 10. The winner will be the individual with the greatest number of votes.

I was given this historical reference regarding the knighting ceremony at least 5 years ago, when Amtgard was something still very fresh and new to me. I wish I could tell you who gave it to me or the author of these words is, but it was so long ago that I received them that I am unable to say now. In their rediscovery, I have come to think over again our roleplay customs with the knighting ceremony. And although I do not agree with all the practices discussed in the article below that were used in the medieval knightings, not to mention that women knights (dames) are not even spoken of, I do admire the solemnity and intent of the event. I hope that it makes others, old and new to the game, think as well. And maybe if thoughts become discussion and discussion becomes action, the face of our knightings may evolve to new heights. Cheers to the Dream!

#### Initiation

A squire was eligible for knighthood when he reached the age of twenty-one. By the thirteenth century the initiation into knighthood had grown into an elaborate religious, almost mystical, ceremony - a far cry from the original Teutonic custom of girding a sword on a youth to mark his transition to manhood.

In times of peace the ceremony usually took place around a major Christian festival such as Easter or Whitsuntide, when it was hoped the weather would be fine enough for much of it to be held outdoors.

Usually several squires were dubbed at one ceremony. At the initiation of the future Edward II in 1306 his father proclaimed that all eligible squires seeking to be dubbed should come to London to share this honour with his son. Two hundred and seventy-six squires turned up and in the crush two were killed, several fainted and fighting broke out which had to be halted before the ceremony could continue.

The ritual of initiation began with a ceremonial bath the night before the dubbing. Even though the bath was primarily for cleanliness it came to be regarded as an act of purification - a second baptism. As the squires sat in wooden bathtubs water would be poured over them. One chronicler tells us of squires who sat fully clothed in the tubs. The aspirants were then asked if they were ready for the water to wash away their former life. On making an affirmative reply, they were then drenched.

Next the young men had their beards and their heads shaved, as an act that symbolized their submission to the will of God. Often they were understandably reluctant to lose all their hair, so only a token lock was removed.

The squires were now ready to be dressed. Each was clothed in a new white tunic, symbolizing purity, under which he would wear a smaller

black tunic with black hose and shoes to remind him of death. Over this would be thrown a magnificent red cloak to show his nobility and his willingness to shed blood for his God and his Church. Finally, a white belt was placed round his waist, denoting his chastity.

Now it was time for the young men to go to church, where they would spend the night in vigil. Placing their new arms on the altar steps, they would pass the night meditating on the ceremony to take place the next day. They were not allowed to sit but had to either stand or kneel throughout the night. Their sponsors or a priest would be at hand to give encouragement if the temptation to sleep became to great.

#### The Vigil

During the vigil the young man would have time to contemplate the duties and responsibilities of knighthood. He might also have repeated this prayer of initiation:

"Hearken we beseech Thee, O Lord, to our prayers, and deign to bless with the right hand of Thy Majesty this sword with which Thy servant desires to be girded, that it may be a defense of churches, widows, orphans and all Thy servants against the scourge of pagans, that it maybe the terror and dread of all evildoers, and that it may be just in both attack and defense."

#### **Dubbings**

The actual initiation took place the following morning following the vigil. In the sight of the whole congregation gathered in the church the squire's sword and arms would be blessed. He would then progress to the place where the arming was to take place. His sponsor would fit his armour. It was held to be auspicious if a woman helped with the arming of a knight and even more so if the woman was the young man's fiancée. When armed with his hauberk, cuirasses, and gauntlets he would then receive his golden spurs, the right one always being attached first. Finally, the sword was girded on so that it hung on the knight's right side.

Fully armed, the new knight would kneel to receive the accolade, or colee, from his sponsor to remind him of the duties of knighthood. Originally, this was a heavy blow delivered to the neck, which would send the young man reeling. In time its force lessened to a gentle tap.

The ceremonious form of initiation was possible only in peacetime, of course. In times of war men were often created knights on the battlefield, the words "Be thou a knight" being a sufficient ceremony. Such initiations gave rise to plucking of three blades of grass, symbolizing the Blessed Trinity, to remind the new knight of his new role in life. Sometimes squires were hastily dubbed before a battle to make up for fighting numbers. The historian, Froissart, claimed that before the battle of Aljubarota in 1385, 140 Spanish knights were created for this reason.

This was doubtless a great morale booster for the army, with so many new knights eager to do honour to their new station in life. Indeed, to be dubbed on the battlefield was often the only way that an impoverished squire could gain knighthood.

During the Hundred Years War, a French squire, Regnault, captured the English Earl of Suffolk. When the Earl discovered that his captor was not a knight, though he was of gentlemanly birth, he dubbed him forthwith: only a knight could capture another knight.

The spirit of initiation was sometimes abused, however. On one occasion, three knights set out on an adventure which, for reasons unknown, needed a fourth knight to make up their numbers. Riding through the fields they came upon a hapless peasant quietly tending his crops. They seized and immediately dubbed the astonished man, then set him on a hose so that they could continue on their quest. Unfortunately, it appears that the poor peasant, rather than the irresponsible knights, was punished for this action.



### The Handshake

In many areas of the world, the handshake is still regarded as a perfectly acceptable method of greeting. It is often the action that sets the lone for most business transactions.

In early days, the handshake was performed by each participant grasping the other participant's forearm and giving a good, firm shake. This assured both parties that the other party was unarmed, and communicated each participant's ability to defend himself in hand-to-hand combat.

In modern times, the handshake has been moved to take place hand to hand, but it is still about the implied message. Please allow me to run through the three most common handshakes and their conveyed messages:

- The Handshake- This is a good, firm handshake. Sometimes it is delivered as bong-crushing, but it is never weak.. This shake lets your companion know that you are confident and that you respect them.
- The Limp WristThis is characterized as a light clasp of the hand. It may be used with women by bone-crushers who are afraid of breaking her hand. (Please break my hand! I'd rather nurse a wound then mistake you for a nancy boy!) the message here is that you have no idea why people shake hands, you do it out of tradition. I now know I can walk all over you, you pansy!
- The Cold Fish- You know it. You hate it. This one is characterized by almost no contact. (In alarming number of people are using this one. The message is loud and clear: I'm too good for you. You have coolies. Please leave me and my obsessive-compulsive, hypochondriac nature alone. (I have actually refused to do business with perpetuators of this particular handshake...just something about them I cannot trust...)

All right, so now you know what to watch out for, both as giver and receiver. Pon't' be a cold fish! Show you're a man! Grab that offered hand and shake it with confidence!


